1. Presidents' report

- Michelle not present—will have more information on insurance through email. For now Michelle's message is that RH district is looking at the State's Blue Cross/Blue Shield plan as the cost of our current plan is a 24% increase. This new plan, if chosen, would not be a high deductible plan. Most Cigna doctors are on this plan. Teachers in the RHTA meeting discussed on their own what they think the new costs could be, but we are still not sure on all things such as copay, RX and ER costs. If we switch over to the new plan, there will be an informational meeting at your building. Kim Davis (our uniserve rep) is involved in this process to see what the district's saving would mean to us and possibly would have to draft a MOU to our contract about this. Note: you will not be able to use an HSA if you we switch from our High Deductible plan, so please make sure that if you are maxing out, you are maxing out by May for the half year and also that you are not going above the prorated MAXING out. (if we switch out of a High Deductible plan). Still not sure about Dental and Eye.
- ➤ Doug-update on Evaluation-for the next school year, the state is implementing a new Evaluation document. A RH subcommittee is working on a document to adapt it into our own RH format.
 - There will be no more scoring (but more conversations of our progress).
 - It will be more collaborative.
 - It will be more about growth
 - Less cumbersome paperwork.
 - It will be rolled out to you before convocation
 - Completed by June
 - Observation is not as formal as it is now and can be a variety of things like "can you observe what I am doing at a department meeting"
 - Still will be two tracks (tenured and non-tenured)
 - However, the state still has some non-negotiables we have to abide by
